Please make sure you avoid the most typical mistakes, paying close attention to the following:

1. In REFERENCES put the TITLE of the edited volume first, **followed by its editor(s)**.
2. Use the format "name of the journal + issue / volume number + COMMA, pages" such as in the presented example: *Cognitive semantics*, 1, p. 55-77.
3. Remember to enter the **place of publication** before the name of the publishing house throughout your references.
4. Differentiate between the hyphen - , which is used mostly in compounds, like *blue-eyed* (morphological level), and the en dash – , which is slightly wider than the hyphen and may substitute a predicate in the sentence (syntactical level). We kindly ask you to use a hyphen identifying the pages of the publication (see item 2) and en dash, when several cities represent the publishing house, like London – New York.
5. Mind that in our Journal we only use a capital letter for the first word of an English title, hence: Cognitive **I**nguistics.

Follow these steps, please:

Step 1. Please send your paper of at least 15 pages (text with references), providing the title and the author's name to our Managing Editors. Follow this text presentation structure: title, author, institution, place, country, abstract with keywords, text, notes / abbreviations, references, contact data. **MAKE SURE YOUR TEXT HAS BEEN PROOFREAD BY A NATIVE SPEAKER PRIOR TO THE SUBMISSION.**

Those authors who use the Cyrillic alphabet should avoid any abbreviations in the list of references, like 'М.', 'К.', 'изд-во', or 'ун-та', i.e. the ones unfamiliar to the wide international audience.

When the articles are uploaded on the platform of our website, the Internet links become active. It is

the author's responsibility to make sure that every Internet link is easily accessed. All the hyperlinks must have the corresponding blue colour both in the text as well as in the list of references.

The authors are requested to check that the **year of publication** of each source and the **pages** consulted coincide with the information given in the text as well as in the list of references.

In our publications, we use Oxford commas and a comma after e.g. and i.e.

Step 2. Please edit your article according to your reviewers' suggestions. React to the remarks in the form of a table (see the example below) or in the margin if requested by your Managing Editor(s).

Step 3. Wait for the Language Editor's remarks. React to the remarks in the form of a table or in the margin if requested by your Language Editor.

Step 4. Discover your Citation Index results.

Step 5. Prepare, sign, and send your Open License Agreement and Author's Rights Transfer. The sample can be downloaded from our home website <https://lartis.sk/guidelines/>. Please fill in the form in Word format using modern versions (the oldest acceptable is **Office 2010**), print it, and then put the date and your signature on it. These two scanned pages must be saved in PDF (other formats are not accepted) as **A SINGLE FILE** consisting of two pages. The name of the file is your surname, e.g., smith.pdf

Step 6. Pay for your publication by transferring the money to our account. The invoice will be sent to your e-mail. It will be in the state language of the country, which issues it, i.e. in Slovak. The publication fee is 250 euros or more depending on the article size (only for papers with international research). Contact the Editor-in-Chief editor@lartis.sk or our Treasurer tatiana.podmakova@ucm.sk for payment details.

Mind that we have no deadlines. We start processing the article as soon as we receive it and publish those first, which are ready for uploading. The rough article processing terms are as follows: Managing Editor (the first technical reading/editing) – 3-5 days + time for editing and final Managing Editor's approval; 2 reviewers – up to 30 days + time for editing and each reviewer's final approval; Language Editor – 2-3 weeks + time for editing and final Language Editor's approval; Managing Editor (the second technical reading/editing) – up to 3 days + time for editing and final Managing

Editor's approval; Urkund system – 1-2 days; the author's final proofreading – up to 7 days. Thus, it may take 6-18 months to prepare and upload your paper. This term also highly depends on how readily the author responds to our remarks.

Traditionally, the number of co-authors in linguistic journals is limited to one or two. We accept the papers with the team consisting of no more than two people. The exception may be made for the international team representing different countries or the research based on many languages.

In order to facilitate the process of editing and correcting your paper, we kindly ask you to respond to the critical remarks using tables.
